1. The price sheet for the after school program is attached. Please choose the program that works best for you keeping in mind that 3 or more days constitute a week. Payments not received by due date will have a late fee of \$5 per day assessed. Additionally, **transportation will be discontinued until payment & all applicable fees are paid in full. We do not generate a payment history; therefore it is advisable to keep all of your receipts.**

2. In the event weekly payment is delinquent for more than one week, a \$5 late fee will be due for the first week, plus \$10 for each additional week thereafter, will be assessed until all unpaid balances are paid in full.

3. A returned check will have a service fee of \$40. For the second returned check a \$45 service charge will be assessed. Additionally, the above credit card will be debited for the returned check(s) plus any outstanding fees, resulting in the right to have all future transactions made in the form of CASH ONLY. Your prompt payment is greatly appreciated.

4. **REFUNDS:** I understand that Karate America has the standard "No Refund" policy. However, as a courtesy, credit may be issued for services, equipment, or uniforms.

5. I UNDERSTAND THAT KARATE AMERICA IS A MARTIAL ARTS SCHOOL AND NOT A DAYCARE IN AS SUCH. THEIR STOCK-IN-TRADE IS NOT SUPERVISION AND CARE. THE INTENT OF KARATE AMERICA IS TO TEACH MARTIAL ARTS PHYSICAL AND PHILOSOPHICAL CHARACTER BUILDING SKILLS. I UNDERSTAND THAT KARATE AMERICA IS A MARTIAL ARTS SCHOOL AND IS A DROP-IN FACILITY IN AS SUCH. MY CHILD(REN) IS/ARE FREE TO COME AND GO. ADDITIONALLY, IF MY CHILD(REN) STAYS AT THE KARATE AMERICA FACILITY IT IS BECAUSE OF MY DIRECTION AND NOT KARATE AMERICA.

The following is a list of In Service Days, Holiday/Vacation Days, Teacher Conference Days and Early Release Days. **Please read through and initial after each one as it lists our policies in relation to these days.**

_____ **Registration Fee**-The first time registration fee is \$99 per child. This fee covers a martial arts uniform, your child's first martial arts belt (to be earned in class) as well as administrative costs. If you have previously been in our program and have simply taken time off and are restarting the program, you will receive 25% off of this fee. The registration fee is waived each year if your child remains in our program on a continuous basis. A continuous basis is considered as being in the after school program and the summer camp program throughout the entire year. Once we receive your completed application, calendar of days/weeks attending and registration fee, your child's place will be reserved in our program. Registration fees are NOT REFUNDABLE for ANY reason.

The following days are included at NO Additional charge for full time students:

_____ **In Service Days**- Our staff will be here from 7:00am – 6:00pm on these days during the regular school year from 9/1/11 – 6/6/12. There is **NO** additional charge for these full days.*

_____ **Teacher Conventions**- Our staff will be here from 7:00am – 6:00pm on these days. There is **NO** additional charge for these full days.*

_____ **Early Release Days**- Our staff will be here by 11:30 am on these days. There is **NO** additional charge for these extended days.*

_____ **PT Compensated Day**- Our staff will be here from 7:00am – 6:00pm on these days. There is **NO** additional charge for these full days.*

_____ *In service, teacher convention and PT compensated days are included at no additional charge for full time (3 or more days a week) members only. Part time members will be charged a fee of \$60/day for these full days.

_____ **Holidays and Vacation Days-** Our school is closed on all holidays. We will also be closed the day after Thanksgiving as well as ALL of the winter/Christmas break so that our staff can spend much deserved time with their families. We WILL be open for the day before Thanksgiving as well as ALL of the spring break in April. The weekly rate for full days is \$174.00 and the daily rate is \$60/day. Please keep in mind that 3 or more days automatically constitute a week.

_____ **Snow days-** The rule of thumb is: If there is a snow day, we will also be closed. This includes early school closures because of snow. It is always best to call us at 835-9554 or 438-5750 if you are unsure.

_____ All students in the After School Program will start out in our basic martial arts program (unless they are already enrolled in Black Belt Training). The basic program will at some point require gear for students. This gear is to keep them safe while doing certain activities in class. We will let you know when this gear should be purchased.

_____ After a period of time, our Chief Instructor may invite your child to join Black Belt Training. The point at which your child is ready for Black Belt Training is determined by our Chief Instructor and is not a given. Students must show that they are ready and committed to earning their Black Belt by following our 5 Key Rating System. A member of our staff will notify you if/when your child is ready for this program.

_____ Every 90 days there is a belt promotion. Students must earn their next belt by learning the curriculum taught in class, handing in their homework book on time, and following our 5 key rating system. The graduation fee for each belt promotion is currently \$30 per child.

_____ **Snacks-** You should pack a snack and drink for your child. All students are required to have a water bottle in their bin. On full days, they should have a morning and afternoon snack as well as a brown bag lunch. We do have snacks and drinks available for purchase. Students can purchase snacks and drinks on a daily or as needed basis or parents can include the cost of snacks and drinks in their weekly tuition. Attached is a complete list of snacks and drinks that we have available as well as a form for parents to sign. Please turn this in with your registration form.
